### Welcome

We will be studying computer concepts and the following applications: Word 2013, Excel 2013, Access 2013 and PowerPoint 2013. The exercises will be accessed through Sam.cengage.com. However, you will have links in sam.cengage.com to download assignments that will require you to create a document using the Office 2013 software. You have access to this software through the campus computer labs or you can download Office 2013 Professional for free from Microsoft. (The instructions and link will be posted in Etudes).

The skills you learn here will help you succeed both in and out of class. However, your education is ultimately YOUR responsibility. YOU determine your level of success. Successful college students are self-motivated. Successful college students understand the importance of studying the material, coming to class prepared and practicing the skills learned. YOU CAN DO IT and I'm here to help.

### Course Description:

The course introduces you to fundamental 'Computer Literacy' concepts. You will learn to use Windows 7 on the PC-compatible computers as well as MS Office 2013 which has the following applications: word processing program (MS Word), a spreadsheet program (MS Excel), a presentation program (MS PowerPoint) and Database (MS Access). Windows 7 will be used to illustrate operating system concepts and disk organization. This class is intended for students requiring 'hands-on' knowledge of computer applications. This class will be accepted as a prerequisite for all advanced applications classes listed under CSIT and CAOT.

1. Describe the usage of computers and why computers are essential components in business and society.
2. Utilize the Internet Web resources and evaluate on-line e-business system.
3. Solve common business problems using appropriate Information Technology applications and systems.
4. Identify categories of programs, system software and applications. Organize and work with files and folders.
5. Describe various types of networks network standards and communication software.
6. Describe digital security risks, privacy, cybercrime and ethics. Discuss big data and application of data analytics.
7. Define and differentiate between the different types of business information systems.
8. Describe steps and usage of the systems development life cycle.
9. Construct formulas for mathematical operations and simple economic analysis, summary statistics. What-if analysis, create various graphs.
10. Identify the elements of a database. Create a database structure. Organize database objects.

A determination of an incomplete grade will be decided in a timely manner.
